The Shares are held in the form of 726,609 of the Company's American Depositary Shares ("ADSs"). Each ADS represents two (2) Shares of the Company. The Adviser, in its capacity as the investment manager of the Funds, has the power to vote and the power to direct the disposition of all Shares held by the Funds. Accordingly, for the purposes of Reg. Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 1,453,218 Shares, or 6.54% of the Company's 22,236,368 Shares deemed issued and outstanding as of August 8, 2019, as reported by the Tel Aviv Stock Exchange. Roderick Wong is the Managing Partner of the Adviser.
